Dear Parent/Carer,

I am writing to tell you about a one-day trip to Boulogne-Sur-Mer available to students of French currently in Year 7. We will leave at around 5.45am on the morning of **Friday 6th June (Block 1) or Friday 13th June (Block 2)** and returning to Hazelwick School at around 10.00pm on Friday evening. The cost of this trip will be in the region of **£132.50** per student. The final cost will be determined once final numbers of students are known. The cost includes:

- Return coach and ferry travel from Hazelwick
- Comprehensive Insurance
- All other visits and activities

The cost of meals is not included in the price, and students will need to bring a packed lunch and a small amount of spending money in euros to purchase any other meals or snacks.

Passports

Students will need their own valid passport to travel outside the UK. Please ensure your child's passport is less than 10 years old on the day of travel and is valid for at least 3 months. In 2025 it is possible that UK Passport Holders will be required to hold an ETIAS visa waiver for entry to EU countries. However, no date has yet been confirmed. We will continue to provide updates around this.

Non-UK or EU Passport Holders

Please check with your embassy for any necessary visa requirements. Additionally, if your child has documents regarding citizenship or right of residency in the UK, please ensure that these documents are taken on the trip.

GHIC cards

Students will also need a Global Health Insurance Card (GHIC). This is available **free of charge** at <https://www.nhs.uk/using-the-nhs/healthcare-abroad/apply-for-a-free-uk-global-health-insurance-card-ghic/> Alternatively a valid EHIC card will still be accepted.

If you wish your child to take part, you are invited to make a voluntary contribution of £67 on the school internet payments system, WisePay by Monday 24th February. Medical and contact details must be verified before making payment. Please also complete the attached form and hand it in to the Trips Office behind reception. I must, however, tell you that as the school could not bear the cost of the visit, the visit will not take place unless all parents/carers, who are able to, are willing to contribute.

Places on the visit are limited to 45 on each day. Should your child get a place on the trip, then I must point out that the first payment is non-returnable.

Should the trip be oversubscribed, students will be selected randomly. If your child is unsuccessful in securing a place, they will be placed on a reserve list and the initial payment refunded. Please note: We reserve the right to withdraw any student whose behavior record at school proves inconsistent with the safe running of the trip.

Please be aware that making an initial payment does not guarantee a place on the trip. If numbers are insufficient to run both day trips, then we will run a single trip. The second payment of £65.50 will be due on 24th March 2025.

As this trip is not required as an essential part of the KS3 French course therefore there is only a limited amount of financial help available for those who are eligible. Please contact trips@hazelwick.org.uk in confidence if you feel that you may qualify.
